Promotion of the above official will be subject to completion of the training in the field of duties and skill development etc. within one year from the date of the meeting of DPC as per recruitment regulations for the post of Medical Record Technician.

On promotion as Medical Record Technician on regular basis, the above official will draw his pay at the minimum of Level-4 in Pay Matrix (Rs.25500-81100) or the existing pay whichever is higher, pending fixation of pay under the relevant rules, wherever necessary.

The promotion of the above official will take effect from the date of assumption of his duties to the promoted post. In case of non-acceptance of the promotion by the official, he will not be considered for promotion for a period of one year from the date of refusal.

On his promotion, the above official may opt for the fixation of pay under FR 22(I)(a)(1), within one month from the date of issue of this order.

The promotion will be subject to such terms and conditions as laid down in the ESI Corporation (Staff & Conditions of Service) Regulations, 2023, as amended from time to time.

Official accepting/declining the promotion may be communicated to this office within a week of issue of this order.
